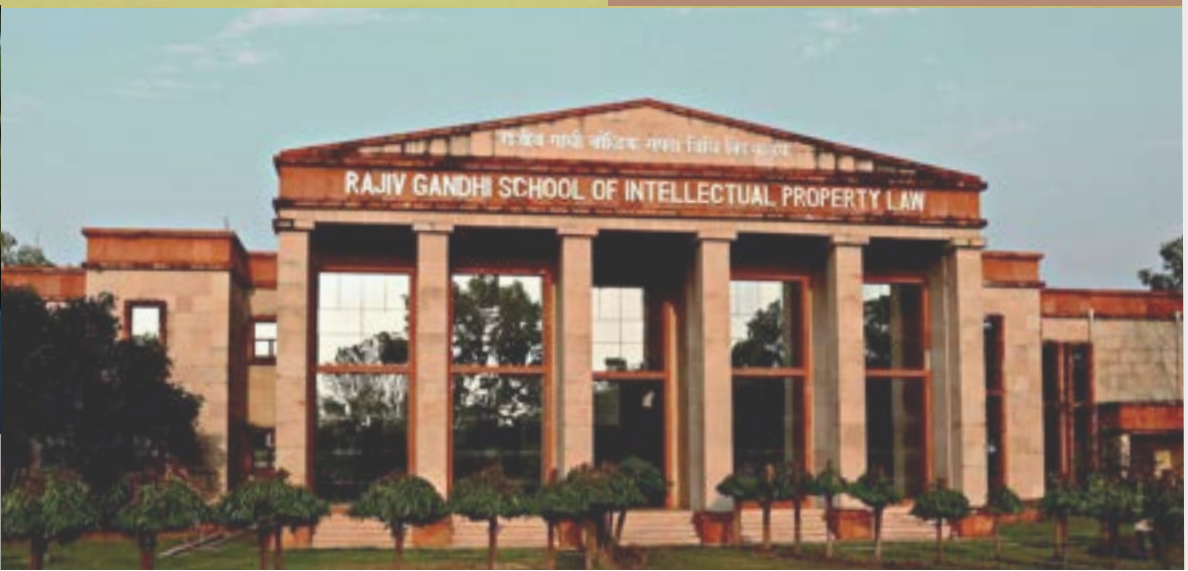
About The School

The Masters' Conference on Intellectual Property (MCIP) 3.0



- The law school organized the third edition of the Master's Conference on Intellectual Property. The conference was conducted from March 24, 2023 to March 26, 2023. Participants including Academicians, Advocates, Research scholars, Post Graduate Students and others, presented their papers.
- The event included three segments: 1. Paper Presentations 2. Essay Writing Competition 3. Policy-Making Competition.
- Theme for this year's paper presentation was "IP and YOUTH: Advocating for Innovation." The theme was inspired by the WIPO, celebrating World Intellectual Property Day. MCIP 3.0 offered a plethora of non-exhaustive sub-themes as well. The authors could make a suitable choice from the given sub-theme or any other topic tangent to the central theme.
- Through MCIP 2023, the focus was on celebrating the "*Can Do*" attitude of marginalized communities and women inventors, creators, and entrepreneurs worldwide and their groundbreaking work.



Guest Lectures

Sri. Ashis Kumar Hazra

Judge Special Court - Durgapur, West Bengal

Sri. Ashis Kumar Hazra, delivered a guest lecture on family litigations to the freshman year students of 2022. The discourse highlighted practical issues related to procedural law and rules of practice. Mr. Hazra emphasized on learning the procedural laws and spoke on matrimonial disputes, adoption, partition, guardianship of minors, preemption and succession in his 2-day lecture series. His lecture detailed out the avenues available to approach the courts for each issue, grounds to file the case and execution of the orders. Mr. Hazra's comparison of the provisions of family law related statutes helped students in better understanding which of those statutes to be invoked for a specific issue. His detailed presentation with comparisons and lively lecture with case laws and live examples from his courtroom certainly enriched the students' learning experience.

On a lighter note, Sri Ashis Kumar Hazra says "Money is flying for advocates who could catch it and while there is dearth of good procedural lawyers and once the students get well versed the future is theirs" - something to reckon.



Sri. Sudipta Kumar De

District and Sessions Judge - Purulia, West Bengal

Sri. Sudipta Kumar De, addressed the final year students of 2022 and delivered a lecture on Drafting and Pleading. Mr. De, guided students through the provisions, explaining them in detail, which helped them get cognizance of nitty gritty details that they would have otherwise missed. For example, his insights on how, even a plaintiff has a provision to file in a written statement (after the defendant submits their's) which will be a part of plaintiff. He also spoke about amendments of plaintiffs and the provisions in CrPC. Students gained more insights on the subject through the details he shared on his experiences being an advocate. Sri. Sudipta Kumar De emphasizes on legal reading in general and the importance of the bare act reading in specific.

Sri. Ashis Kumar Hazra and Sri. Sudipta Kumar De also distributed the prizes to the students whose participation won RGSOIPL first runner up position in the debate competition held by the Ministry of Law and Justice as part of the Har Ghar Tiranga campaign of India's 75th Independence day celebrations.

Professor Purvi Pokhariyal

Dean of School Of Law Forensic Justice And Policy Studies- Gandhinagar, Gujarat

Professor Purvi Pokhariyal is the Director of Campus, Academics and Research at the National Forensic Sciences University, Gandhinagar. She specializes in Criminal Justice and Justice Education. Prof. Pokhariyal has the distinction of being the first female chairperson of the Indian Society of Criminology. She is a visiting faculty at HOF University, Germany.

Prof. Pokhariyal delivered a lecture on "Forensic evidence building for Legal professionals". She started with the basics of the Criminal Justice system, its pillars, followed by a comparison of conviction rates among various countries and the fundamentals of Forensic Science, emphasizing the importance of forensic science in criminal procedure. She laid down the challenges faced by the domain and the way forward being proper training of candidates and appreciation by the Judiciary.



National Runners-Up on HAR GHAR TIIRANGA

In its extended effort to celebrate Azadi Ka Mahotsav, the department of Legal affairs, the Ministry of Law and Justice, the government of India initiated Har Ghar Thiranga. A national-level debate competition on constitutional issues was held under its aegis. A debate on the topic "Whether India needs a UCC?" was conducted by the Pro Bono club, in which 8 students participated. A video and transcript of the same were sent as an entry to the national competition by the final year LLB student Mathews Savio, which secured the first runners-up position at the National level.



Constitution Day Celebration

The Technology Students' Gymkhana in collaboration with the Pro Bono club of RGSOIPL, celebrated Constitution Day. The Dean, RGSOIPL, and President TSG inaugurated the event. To commemorate the Day, Professor KD Raju, RGSOIPL, guided the NCC cadets and the students of IIT Kharagpur in reading the preamble of the constitution of India. Following this, Law students engaged in a thought-provoking debate on the reformation of the collegium system.

Anti Ragging Awareness Event

The law school organized an anti-ragging awareness program for the institute's students under the aegis of the Pro Bono club IIT Kharagpur. Shri. Soumen Mitra, IPS (Retd.), Former Commissioner of Police, Kolkata, was the Chief Guest of the function and delivered the keynote address. The formal program was followed by a skit by the students of the Law School depicting the nuances of ragging and why not to indulge in it, and a Q&A session with the guests. The attendees gained an accurate understanding of what constitutes ragging and its consequences for both the victim and perpetrators. The message of "Say no to Ragging" was imbibed in everyone.



FROM THE COURTS

Don't rely on crowd-sourced resources like Wikipedia; Supreme Court cautions Courts & Adjudicating Authorities

Hewlett Packard India Sales Pvt. Ltd v. Commissioner of Customs (Import), 2023 SCC OnLine SC 31.

While dealing with a case where the Commissioner of Customs (Appeal) had referred to Wikipedia to come to a conclusion in a case, the bench of Justice Surya Kant and Justice Vikram Nath, has cautioned the adjudicating authorities against completely relying on such online sources. While the Court acknowledged the utility of these platforms which provide free access to knowledge across the globe, it also cautioned against using such sources for legal dispute resolution as, despite being a treasure trove of knowledge, such resources are based on a crowd-sourced and user-generated editing model that is not completely dependable in terms of academic veracity and can promote misleading information as has been noted by this court on previous occasions also.

Writ petition under Article 226 maintainable even in contract cases if State fails to be fair or practices discrimination: the Supreme Court

M/S Gas Authority of India Limited v. M/S Indian Petrochemicals Corporation Limited and Ors., 2023 LiveLaw (SC)88.

A division bench of Justices Sanjay Kishan Kaul and Justice Abhay S Oka held that the writ jurisdiction of the High Court under Article 226 can be exercised even in contractual dealings if the government fails to exercise fairness or practices discrimination. The Court made the observation while upholding a Gujarat High Court decision to grant relief to Indian Petrochemicals Corporation Ltd. (IPCL) in the exercise of the Court's writ jurisdiction in a contractual dispute with the Gas Authority of India Limited (GAIL). On the issue of maintainability, the Court noted that the writ petition was maintainable since GAIL was a public undertaking and, therefore, a 'State' under Article 12 of the Constitution. Pertinently, the Court added, "Further, writ jurisdiction can be exercised when the State, even in its contractual dealings, fails to exercise a degree of fairness or practices any discrimination.

Supreme Court upholds validity of All India Bar Examination; BCI to decide whether it should be held pre or post-enrolment

Bar Council of India v. Bonnie Foi Law College, 2023 SCC Online SC 130.

A Constitution bench of Justices Sanjay Kishan Kaul, Justice Sanjiv Khanna, Justice AS Oka, Justice Vikram Nath and Justice JK Maheshwari upheld the validity of the All India Bar Examination (AIBE) that law graduates are required to take to be allowed to practice before courts. The Court held that the powers of the Bar Council of India (BCI) to conduct the exam were adequate, adding, "We are, thus, of the view that while considering the questions referred to us, the only conclusion which can be laid is that the interdict placed by the judgment of this Court in V. Sudeer on the powers of the Bar Council of India cannot be sustained and we cannot hold that V. Sudeer lays down the correct position of law."

On whether the AIBE should be held pre or post-enrolment, the Court said, "The effect of the view expressed by us would be that it has to be left to the Bar Council of India as to at what stage the All India Bar Examination has to be held – pre or post." The bench noted that while there are consequences, especially in respect of the interregnum period, which would arise in holding the AIBE in either scenario, it was not for the Supreme Court to delve into them. "But it would be appropriate to leave it to the Bar Council of India to look at the niceties of both situations," the judgment stated. The Court also called for an appropriate rule to be framed laying down that an enrolled advocate who takes up employment in a non legal context for a substantial period would be deemed to be a new enrollee, and would be required to take AIBE again. "We believe that the requirements of an active legal practice and that of an unconnected job are different. Even if a person has a law degree or enrolment, it does not mean that his ability to assist the court would continue with him if there is a long hiatus period of time in some unconnected job. He would have to hone and test his skills afresh," the Court said.

Supreme Court upholds Centre's decision of demonetizing Rs. 500 and Rs. 1000 currency notes

Vivek Narayan Sharma v. Union of India 2023 LiveLaw SC 1

In a petition against the demonetization of Rs. 500 and Rs. 1000 currency notes in 2016, the Constitution Bench has upheld the Centre's 2016 demonetization scheme in a 4:1 majority and held that demonetization was proportionate to the Union's stated objectives and was implemented in a reasonable manner. In a majority opinion, the court, while answering with respect to the power available to the Central government under section 26(2) of the RBI Act, 1934, held that "The interpretation leading to absurdity, and which renders a provision to be futile, must be avoided. Any interpretation which advances the purpose and object of the legislation must be preferred when two constructions can be done. Thus, a restrictive interpretation of the term "any" cannot be given." In conclusion the court said that power available to the Central Government under Section 26(2) of RBI Act cannot be restricted and can be exercised for all series of bank notes. Similarly while deciding on the decision making process the Court held that "the decision making process cannot be termed as a fraud in law, merely because the procedure has emanated from the Central Government. The term "recommendation" must be construed in the context of the statutory scheme."

Dissenting Opinion: Justice B.V Nagarathna, J note that the Majority's judgment does not recognize the essential fact that Section 26(2) does not consider the initiation of demonetization by banks noted by the Central Government. It contemplated the demonetization by the Central Board of RBI. Hence, if demonetization must be initiated by the Central Government, then such power must be derived from Entry 36 List 1, Seventh Schedule, which provides for currency, coinage, legal tender, and foreign exchange. She held that demonetization of the whole series of Rs 500 and Rs 1000 currency notes is a serious matter, and it could not be done by the Centre by merely issuing a Gazette Notification.

- **Sec. 375 (2019):** An Indian Hindi language movie. A defense lawyer who believes that lawyers are in the business of law, not justice. This movie will raise doubts in the minds of students of law as to what is professional ethics of a lawyer.

- **12 Angry Men (1957):** An American courtroom drama about 12 jury members. What transpires in a jury room during their deliberations in a murder trial? This movie will allow a student of law to have an understanding of what 'reasonable doubt' means.

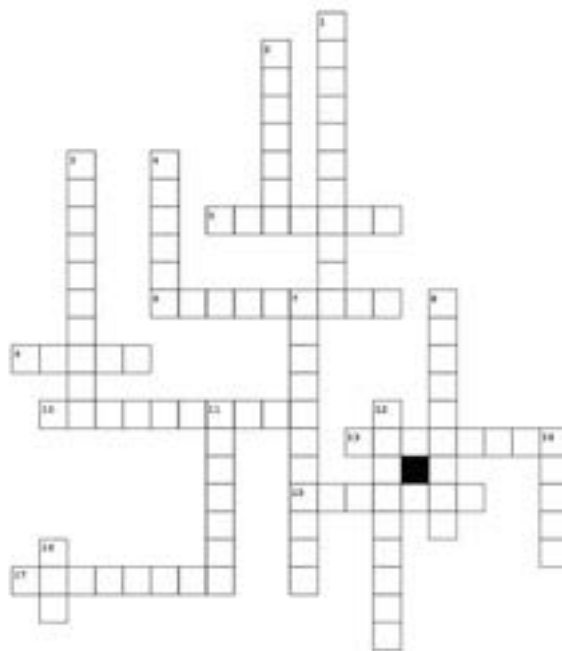
